Arts Nova Scotia recognizes the Treaties of Peace and Friendship, and we aim to use them as a guide for our interactions with the land and with the people of this land as well to inform how we develop and implement our programs and policies.

Message from the Chair, 2021-22

As I write this report in May of 2022, it's difficult to encapsulate the previous year without acknowledging that it has been so many different things to different people.

This time last year in Nova Scotia we were emerging from a difficult wave of COVID-19 and a complete lockdown that prevented people from crossing provincial borders. Since then we've experienced encouraging moves to normalcy punctuated by sudden left-turns into new and unknown perils. For some, the current moment is a relief, in that our lives may increasingly resemble what they were pre-pandemic and many activities



can begin again. For others, the impact of the pandemic is ongoing, resilience is low and many difficult decisions are ahead.

One of our challenges at Arts Nova Scotia is to recognize and respond to the shifting needs of the communities we serve—especially in a moment of static resources and unprecedented inflation. The inequities that were plainly amplified by the pandemic remain. Arts Nova Scotia has an important role in ensuring that equity, diversity, inclusion, and accessibility are all addressed in both the programs that we administer but also in the greater community we serve.

With this in mind Arts NS is engaging in a strategic planning process to help us prioritize how to best use our resources to continue supporting Nova Scotia's creators while also ensuring that we are addressing the most pressing priorities of our society. I look forward to being able to report on the results of that process soon.

I would like to take a moment to recognize the contributions of two departing board members who have made a very significant contribution to Arts Nova Scotia – Nancy Noble and Jack Chen. Both Nancy and Jack brought a wealth of experience, intelligence and good humour to our conversations, rolled up their sleeves when needed, and left a positive legacy behind. A "standing ovation" to both of you.

My message cannot be complete without recognizing the entire staff at Arts Nova Scotia for their incredible hard work, thoughtfulness, flexibility and commitment to serve. I'm proud to volunteer for an organization that demonstrates the kind of excellent leadership that is exemplified by these people.

Director's Report 2021-22

As the arts community navigated the optimism of re-opening to the devastation of suddenly shutting down, they proved once again their resilience. Riding the rollercoaster of emotions through this unknown period can be both terrifying and exhilarating. The sector has pushed into new territory and will need to face challenges head on as we work collectively to ensure our practices are equitable, accessible and inclusive for all



creatives and audiences.

For many artists and arts organizations who were able to produce and present work these past two years, there have been moments of incredible joy and wonder. We no longer take for granted the impact of gathering for live performance or an exhibition opening. As a provincial funding agency, our work will focus on how to best support professional arts community creation coming out of multiple crises. Arts Nova Scotia has initiated a planning process to determine our strategic priorities for the next three years. We will build on the themes and findings from the "Building Back Better" report to ground our work, as well as the important work echoed by colleagues

across the country and globally. As we begin to outline our direction, we will share back to create conversation and invite feedback into our progress.

The function of this Annual Report, as you will read in the following pages, is to provide a brief snapshot of the previous year's activities and highlight achievements. We continue to work closely year with our colleagues in the Culture and Heritage Development division to direct funds to highly subscribed grant programs. Through Support4Culture funding, we were able to increase success rates for individual artist projects and project grants to organizations. We also worked in partnership with the Department of Communities, Culture, Tourism and Heritage to recommend support for the Atlantic Disability Arts Symposium and *Artists in Mind*, a report on artists' mental health and well being in Nova Scotia. I am grateful to the amazingly dedicated Board of Directors, chaired by Ken Schwartz, whose collective knowledge has steered our agency through another year of the pandemic. I am also grateful to my colleagues, the staff at Arts Nova Scotia, Enrique, David, and Lauren, for their outstanding professionalism and commitment to artists and arts organizations in this ever-challenging time. Their care and flexible approach to programs shone through and I'm so thankful for their ability to challenge the status quo, work through problems together and fill in gaps as necessary. I would also like to thank the team at the Culture and Heritage Division for their partnership and support. Our approach has always been collaborative but there is an increased effort to pool our resources to ensure we are supporting the sector to the best of our abilities.

Peer Assessment Committees review applications and make final decisions on which applications receive support. They are used for the following programs: Grants to Individuals, Grants to Organizations and Groups, Arts Equity Program, Artistic Innovation, and the Nova Scotia Art Bank Purchase Program. They are also used for the following awards: Prix Grand-Pré, Creative Community Impact Award, Artist Recognition Awards, and Portia White Prize. Additionally, peer assessment committees review all applications for the Operating Grants to Arts Organizations program and make recommendations for funding. These recommendations go to the Board of Arts Nova Scotia for final approval.

Featured Projects

Koqm by El'tuek Qokom

Koqm, a full-length solo theatrical piece journeys through time and land to experience the voices and embodiment of fictional L'nu (also termed Mi'kmaw) women. The production is created by theatre artists shalan joudry, Ken Schwartz, and Ann-Marie Kerr.

The first phase of rehearsal took place in Canning, NS, October 2021, followed by a second phase of rehearsal and performances in Annapolis Royal, NS at King's Theatre in November 2021."

The piece has also debuted at the Neptune Theatre in Halifax and will be presented at Ship's Company Theatre in Parrsboro, August 2022.

A Mural in Memory: Celebrating the Children of Uniacke Square by Leticia Fraser

St. George's YouthNet commissioned artist, African Nova Scotian visual artist Leticia Fraser to "create and design a mural that depicts participants in our youth programs, and more broadly, children that live in Uniacke Square. In doing so, we will remember the legacy of Naomi Kidston, who was brutally murdered in 2005. Naomi was once a staff member at St. George's YouthNet and beloved member of the Unaicke Square community."

Véronique MacKenzie attends artist residency at The Chateau Orquevaux, France

Like so many projects in the past two years, Véronique had to delay her artist residency due to the COVID-19 pandemic, however she travelled to France in 2022.

Véronique writes, "the project is about losing one's mother tongue. To facilitate the first phase of this solo creation project titled "Lost Language" (working title), I will be attending The Chateau Orquevaux International Artist and Writers Residency in Orquevaux, France, with its location being close to the birth and childhood homes of my mother (Nancy/Dijon). This residency will offer a cultural immersion with a small French community whilst living with other artists and it will feed the practice of creation specific to my subject of cultural identity and loss of mother tongue, a phenomenon increasingly experienced by many children of migrants".

Self-Portrait Masks, Movement and Media by Miya Turnbull

Miya Turnbull's Self-Portraits series are in the form of masks, sculptures, performances, photographs and video. This new work is an integration of art, movement, craft and new media: a multitude of faces, each with a slightly different gaze, yet recognizably consistent throughout.

"I am using masks as a metaphor for persona, self-image and identity. I draw from and challenge the traditional uses of masks worn for disguise, masquerade (theatre), transformation (ceremonies) and protection (pandemic). Each mask will be a portrait of myself in some form; I will create numerous iterations of my image as a way to explore different facets of my identity and the space 'in-between' public and private, beauty and distortion, and in my case, as bi-racial (Japanese/Caucasian)."

The work from this project, titled *In-Between* is exhibiting at Eltuek Arts Centre, until Sept 1, 2022.

Mi'kmaq Arts Program

The Mi'kmag Arts Program was launched in 2019 to support Mi'kmag arts and culture in Mi'kma'ki. In 2021, seven projects were funded following the recommendation of a peer assessment committee of three professional, practicing Mi'kmag artists. The successful projects included the mentoring of youth by Marlene Joudry to learn and engage in the preservation, creation and dissemination of traditional Mi'kmag Porcupine Quill work in a contemporary context; building an ocean-going birch bark canoe by Melissa Labrador, in collaboration with Todd Labrador; the creation of new bead and quillwork by Jocelyn Marshall; assisting Amanda Peters with tuition costs for her MFA and to complete her thesis, "The Berry Pickers"; making traditional regalia for the Call to Bar ceremony by Marissa Prosper; Jayme-Lynn Gloade created her own ceremony out of making wares/vessels, breaking them, and devoting time to rebuilding to represent the dysfunction between Indigenous & Settler people in Canada; and regalia maker and ribbon skirt maker, Michelle Roy shared her ribbon skirt knowledge with Mi'kmag women to create their own ribbon skirts for their families.





Melissa Labrador – Kespukwitk Kwitn

"Over the past 17 years I have had the opportunity to work along side Todd (my Father) on occasion to create 12, 16, 19, and 21 foot canoes. This opportunity came up to collaborate with Todd (the only known practicing L'nug canoe builder) on the largest canoe to date built between us; a 22ft ocean-going birch bark canoe built in the traditions we have learned and are carrying on alone. Beside being the largest canoe we would have ever collaborated on, this canoe may be one of the last large canoe projects due to the climate emergency we are facing and the effects it is having on the harvesting and collection of raw materials."

Access Support

Eight successful Grants to Organizations and Groups projects received Access Support funding in 2021-2022 for a total of \$16,125. Organizations used these funds to create more accessible projects for the public and artists by providing ASL interpretation for live performances, live closed captioning for online panels, and transcription for video materials. Funds were also used to hire accessibility consultants, commission visual accompaniments for sound installations, and provide support workers for individual artists. The successful projects included: Nocturne, "Return Current II"; IOTA Institute, "Artist-led Virtual Environments"; Matchstick Theatre, "David French's play Leaving Home"; The Tidal River Collective, "The Tidal River Residency professional development series" Eyelevel Gallery, "Meet Me at the Dinner Table: A Series of Hardy Conversations & Delicious Food (working title)"; EVERYSEEKER "Parallel Frequencies"; The Digidamara Group, "Digidamara Pilot Production"; Afterwords Literary Festival, "Engagement the Climate".

Daren Okafo (Vice-Chair), Halifax, Halifax Regional Municipality, is originally from Dublin, Ireland, but has been living and working in Nova Scotia for over 30 years. He has worked and studied in community engagement and radical adult education across the globe. As a hip-hop musician and DJ, Daren produced work for a number of local figures, scored music for CBC and MTV as well as performed at several major international festivals.

Sarah O'Toole, Antigonish, Antigonish County, is a creative collaborator and community developer living in Antigonish with her spouse and three children. She works with community stakeholders to centre the role of artists and creative expression in community life.

Liliona Quarmyne, Halifax, Halifax Regional Municipality, is a Ghanaian/Filipino choreographer, dance, actor and facilitator whose work draws from her eclectic background and explores the intersections of art and social justice.

Ken Schwartz (Chair), Canning, Kings County, is the Artistic Director of Two Planks and a Passion Theatre and the co-founder of the Ross Creek Centre for the Arts.

STRATEGIC INITIATIVES

Building Back Better — A Vision for Culture Sector Recovery in Nova Scotia

Building Back Better outlines a course of action to invest in arts and culture to recover from the effects of the COVID-19 pandemic but also charts a path forward to revitalize and revision the sector.

In the spring of 2021, Arts Nova Scotia and the Creative Nova Scotia Leadership Council undertook a series of consultation sessions with stakeholders representing a broad cross-section of the arts and culture sector throughout the province to gather feedback on upcoming recovery efforts. These conversations focused on the challenges the sector faced over the course of the pandemic and asked what changes they consider central to revitalizing the economic and creative heart of the culture sector. Close to 200 stakeholders participated in these sessions – both virtually and through an email survey. Based on our conversations and the analysis of the data, six major themes emerged.

- 1. Operational funding for arts and culture organizations needs to be increased
- 2. Use Equity, Diversity and Inclusion as a lens through which we choose to invigorate the sector
- 3. Focus on the sustainability of the sector, not one-time funding
- 4. The language of "innovation" and "export" are perceived as barriers to growth
- 5. More support is needed to increase and assess digital capacity throughout the sector
- 6. Institute measures to rebuild the vitality of the sector and reposition culture as a primary economic driver for recovery

Arts Nova Scotia continues to work with the Creative Nova Scotia Leadership Council to advocate for these recommendations to be implemented. Arts Nova Scotia will also use the findings in this report as a foundation to build its strategic priorities for the upcoming year.

Creative Nova Scotia Awards 2021

Presented by Arts Nova Scotia and the Creative Nova Scotia Leadership Council, the Creative Nova Scotia Awards Gala is a yearly event that celebrates excellence in artistic achievement, notably in the announcements of two major awards, the Portia White Prize and the Lieutenant Governor of Nova Scotia Masterworks Arts Award. Winners of the Prix Grand-Pré, the Established Artist Recognition Awards, the Emerging Artist Recognition Awards, the Indigenous Artist Award, the Black Artist Recognition Award and the Creative Community Impact Awards are also honoured. Collectively, the awards are worth \$95,000.

For the inaugural Black Artist Recognition Award, ceramic artist and potter Julian Covey was commissioned to create a new physical award.

From Julian: "This piece is inspired by movement, energy and creative force. I am interested in the idea of artists as pillars in the community in combination with the symbolic imagery of trees (which are often associated with wisdom, resilience and physical/spiritual nourishment)".

PROGRAM SUMMARY

As the provincial funding agency, Arts Nova Scotia provides support to professional artists, arts organizations, arts education programs, and a several important arts awards and prizes. This significant investment in artists and cultural infrastructure encourages creative, healthy and prosperous communities across the region.

GRANTS TO INDIVIDUALS

Supports the creation of new works by professional artists in all disciplines including fine crafts, literary, visual, media and performing arts. It also promotes a broad understanding and appreciation of art and artists through professional development, creation and presentation of work. Individual artists may submit one application per grant per deadline.

GRANTS TO ORGANIZATIONS AND SMALL GROUPS

Supports artistic development through the production of a specific work or program for presentation to the public, the commissioning of new work and professional development for organizations.

OPERATING ASSISTANCE TO ARTS ORGANIZATIONS

Designed to enhance stability within established professional arts organizations Support is provided to organizations that produce or present artistic performances and events involving professional artists. Such organizations are fundamental to the vitality and long-term health of the arts and cultural life in Nova Scotia.

NOVA SCOTIA ART BANK

Every year the Nova Scotia Art Bank adds to its collection through Purchase Program. Artists are invited to submit their works for consideration. Pieces that are acquired become part of a working collection. They are maintained, loaned out and displayed in government offices and agencies. The program raises awareness of artists and their works and stimulates interest in visual arts and craft.

SUPPORT4CULTURE

Support4Culture is designed to encourage excellence in the arts, grown the culture sector and foster innovation. Arts Nova Scotia will benefit from this partnership between the Department of Communities, Culture, Tourism and Heritage and the Nova Scotia Gaming Corporation.

ACCESS SUPPORT

Access Support is a supplement to a project grant that funds individual applicants who self-identify as Deaf, having disabilities or living with mental illness, as well as groups and organizations who want to increase the accessibility to their presentation/ production for audience and/or participants. This supplementary grant provides a contribution towards costs for specific services and supports required to carry out a project funded by Arts NS.

ARTS EQUITY INITIATIVE

Designed to support artistic growth, development, production and dissemination, the initiative is available to the following designated communities of artists: Indigenous; Culturally diverse (African Nova Scotian and other visible minorities of African, Asian, Latin American, Middle Eastern and mixed racial descents; Artists who are deaf, have disabilities or are living with mental illness.

CREATIVE COLLABORATIONS

An internal fund that looks at underserved areas within its granting programs. The program is integrated into the peer assessment process for the Grants to Individuals and the Grants to Organizations and Groups competitions based on strategic priorities identified by the Board. We continue to focus on first time funded applications and projects that take place outside of Halifax Regional Municipality. While artistic excellence remains the core of peer assessed evaluation, the fund can be used to augment success rates in disciplines or regions within identified communities. We were able to fund an additional 24 projects through this fund.

ARTISTIC INNOVATION

The Artistic Innovation program was implemented as a short-term plan to stimulate artistic excellence and start a new relationship with the core art organizations and their publics. Additional expenses due to COVID-19 continue, therefore we provided eligible organizations one-time grants divided equally amongst 15 organizations who receive operating support from Arts Nova Scotia.

ANNUAL INVESTMENTS

ARTISTS IN THE SCHOOLS

Arts Nova Scotia provides support to four artists in the schools programs (Perform, PAINTS, WITS, and Arts Smarts) that are designed to bring professional artists together with students and teachers across Nova Scotia to expand and explore creativity, self-expression, and critical thinking through artistic practice.

NOVA SCOTIA TALENT TRUST

NSTT provides scholarships to Nova Scotians who demonstrate exceptional potential and commitment to become established artists in their chosen fields. Applicants of any age may apply but support is given to those who are not yet established in their fields and who are undertaking programs of study which will advance their artistic development and who are pursuing career paths that can lead them to become established artists.

THE LIEUTENANT GOVERNOR OF NOVA SCOTIA MASTERWORKS ARTS AWARD

The LG Masterworks Foundation oversees and manages all aspects of this award. First presented in 2006, this \$25,000 annual award looks to recognize, reward and encourage excellence in all creative media and to highlight works that have a strong connection to Nova Scotia in the context of national and international achievement. The award is presented at the Creative Nova Scotia Awards Gala.

MI'KMAQ ARTS PROGRAM

The Mi'kmaq Arts Program supports the development and continuation of Mi'kmaq art forms in the territory of Mi'kma'ki (Nova Scotia). Arts Nova Scotia recognizes the specific needs and practices of the Mi'kmaq arts community and acknowledges a new funding program is required.
